Reason for Amendment

On the 2013 Form 990 as originally filed, the minister's housing allowance paid to the President was unintentionally included on 990 Part VII, Section A in both Column (D) Reportable Compensation and Column (F) Other Compensation. This also overstated compensation on 990 Part IX, Line 5 and understated compensation on 990 Part IX, Line 7.

The return has been amended to now correctly report the minister's housing allowance in Column (F) alone and not in column (D). Compensation has also been adjusted on 990 Part IX.
